#### 课程简介:

Broadly speaking, the course will explore sociological understanding of law, legal institutions, and "law in action". The course will provide students with an overview of the role that law plays in modern society. We will examine how the law not only shapes society but is itself transformed by social factors. The first part of the course will explore major historical and theoretical traditions within sociolegal studies, with an emphasis on relevant theoretical statements by core social thinkers such as Durkheim, Marx, Weber, and Foucault. We will examine how these theories continue to influence our understanding of the law today. The second part of the course draws from both theoretical and empirical work to discuss specific topics, including law and social change, legal consciousness, law mobilization and dispute resolution, legal profession and the globalization of law, etc.
