# 课程介绍

根据美国社会学家弗雷格斯坦(Neil Fligstein)的说法,社会学理论是一门很难教的课程,不同老师可以选择他们认为重要的进行讲授,选择他们喜欢的而忽略他们认为不相关的内容。在以理论见长的伯克利社会学系,布洛维(Burawoy)和弗雷格斯坦的理论课内容几乎是没有重叠的。研究生课程只有八周,时间有限,本课程所选择的内容基于以下考虑:第一周首先要思考讨论的问题有,理论是什么?理论的目的是什么?社会学家理解的理论有哪些类型?理论和社会学话语是什么关系?话语、理论背后的文化、政治是什么?如何理解、运用和批判西方社会学理论?如何立足中国大地发展社会学理论?如何提升写文章的理论深度?然后接下来的7周将讨论戈夫曼(拟剧论、污名理论和框架分析)、贝克的风险社会理论、吉登斯结构化理论、布迪厄的文化资本、场域理论,社会网络分析和制度主义理论。第一周的问题会贯穿在具体理论的学习中。具体理论的文献中既有经典的理论文章,也有理论应用的实证文章。

本课程的目的在于提升学生批判性地运用理论分析和研究社会现象的能力,激发学生发展自己研究课题和建构自身理论的想象力和冲动。课程讲授语言主要是中文。

#### **Course description:**

According to American Sociologist Neil Fligstein, teaching theory is a difficult task. Individual faculty members can choose what they think is important to teach. They can

choose texts that they like and ignore texts they do not deem relevant. Berkeley sociology is strong in theory, however, the theory courses taught by Burawoy and Fligstein are almost complete different. We have eight weeks, due to time limitation, the texts chosen for this course are out of the following consideration. In the first week we will discuss several questions, what is theory? what is theory for? What do sociologists mean by theories? What is the relationship between the theories and sociological discourse? What are the culture and politics behind the theories and discourse? How to understand, use and criticize Western sociological theories? How to take a foothold in China to develop sociological theories? How to theorize an academic paper? In the following seven weeks the course will introduce and discuss the following theories, including Goffman's theory (dramaturgical theory, stigmatizing theory and framework analysis), Beck's risk society theory, Giddens' structuration theory, Bourdieu's theory (cultural capital, and field theory), social network analysis and institutional theory. The questions in the first week will go through the study of each theory. The texts include classical theories and empirical papers which applied those theories in research.

This course aims to improve students' ability in applying the theories to analyze social phenomenon and do social research in a critical way, and inspire students' impulse and imagination in developing their own research projects and theories. This course will be mainly taught in Chinese.

# 课程要求和评价

希望同学们课前完成当周要求的必读文献和至少两篇推荐阅读,带着思考和问题到课堂。

课堂参与: 15%, 鼓励积极发言。可能随机抽取学生发言,无故缺席两次整个课程按退课处理,计分为0:允许请假1次。

#### 作业:

小组作业:全班随机分成7组,各负责除第一周之外7周中一周的所有阅读文献,进行简单总结,重点评论哪些内容使你信服有启发,哪些内容有困惑觉得需要讨论,哪些内容觉得有欠缺以及为什么,如何运用该理论以及如何进一步发展该理论等,3000-4000字。无需ppt展示,课堂会随机提问口头汇报阐述相应内容。占比20%

个人作业:每人自主选择除第一周和小组作业之外 6 周中的 2 周内容,写 2 篇 reading responses,每篇占比 10%。1000 字以内,需要涉及必读文献和 2 篇推荐阅读文献,主要是谈对文献的疑惑、问题和运用发展思路。

周四上课前的周三中午12点之前上传到学在浙大课程群。

## 期末论文:

占比 45%, 4500-6000 字。

期末论文可以选用以下方式之一: a, 选取本学期的某个理论, 结合自己感兴趣的研究, 写一篇研究设计; b, 围绕本学期的某个理论, 结合相关研究, 探讨其不足和需要向前推进之处; c,选取本学期 2-3 位理论家, 比较分析各位的相同之处和不同之处。递交时间: 课程结束后第三个周三中午 12 点。
